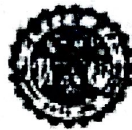

1. **Name** : SNEHAGIRI MISSIONARY SISTERS SOCIETY
2. **Office** : MAHIPPUR ROAD, GHOSLA TEHSIL MAHIPPUR DISTT. UJJAIN
3. **Area of operation** : Whole M.P.
4. **Objectives of the Society** :
 1. To promote and perform religious, educational, medical and social services.
 2. Promotion of science, education, literature or fine arts;
 3. Provision of maintenance of libraries or reading rooms for general use among the members or upon to the public;
 4. Promotion of social welfare;
 5. Promotion of religious or charitable purpose including establishment of funds for public welfare;
 6. Promotion of implementation of the different schemes sponsored by the State Government OR of the Central Government;
 7. To purchase, take on lease, or in exchange or otherwise acquire any land buildings, assessments or other movable or immovable properties which may be requisite for the purpose of the society and to sell, demise, lease, rent out, mortgage, give in exchange, surrender or dispose of them.
 8. To erect, construct or otherwise provide convents, chapels, training centers, study house, schools, colleges, hostels, libraries, reading rooms, dispensaries, orphanages, poor homes and other religious, educational, medical and charitable institution and administer them and maintain, alter, repair, improve, demolish or reconstruct the same or any part thereof in any part of India irrespective of religions, race, community, caste or social status.
 9. To make bye-laws not inconsistent with memorandum of Association for the proper administration of the society and its institutions, but any amended clause of the bye-laws shall come into force only when, it is approved by Registrar of societies.
5. **Membership of the society** :
 - a) Application for the membership will be put up before the governing body who will accept or reject the application. When an application for the membership is accepted a copy of the name and signature of the member shall be made in the membership Roll of the society
 - b) Only the members of the congregation of the Sisters of Jesus who have made their final profession are eligible for the membership.
 - c) The number of membership of the society shall not be less than seven.

6. Cessation of Membership :

- A member shall cease to be a member of the society.
- if she resigns by writing and her resignation is accepted by the governing body.
 - If she is dead.
 - If she has become lunatic.
 - If she is expelled by the Governing Body for any charge of misconduct.
 - When a person ceases to be a member of the S.M.S. congregation.
 - If she is not a major.
 - On remaining absent constantly for three times in the meeting of Governing



7. Membership Fees :

No fees or subscription of any kind shall be levied on the members as such.

8. Membership Register :

The society shall keep the membership register containing names, addresses, age, occupation, date of membership, date of termination / cessation of membership and signatures of the members.

9. GENERAL MEETING: -

All members as per Rule 5 shall participate in the meeting.

Annual General meeting shall be held once in a year. The first meeting of the General Body shall be held within three months from the date of registration to elect the first Governing body. The President may call for any other General meeting of the Society whenever he/she considers it necessary to do so. The quorum for a General meeting shall be of 3 members. Voting shall be either by secret ballot, or show of hands and in the event of the votes being equal the person presiding over the particular meeting shall have an additional casting vote.

9A. The Governing Body :-
